I, the undersigned have honour to state that a large numbers of Kuki Militants having with deadly sophisticated weapons have stormed and burnt down my house and all Meitei inhabited areas of Serou Bazar on 3rd. 2023 at @10:00 p.m. In such incident of violence I have lost all valuable items of properties as follows:-

- (1) Pakka House two storey with 4 rooms. (2) 1 No of bath room and 1 No of toilet of pakka constn. (3) 1 No of Washing Machine & 1 Freeze Machine (4) 3 Nos double wooden Almirah. (5) 4 Nos of wooden double beds. (6) all the valuable family clothes of garments. (7) 1 Nos. Dio vehicle (8) 2 Nos of bi-cycle (9) 4 Nos motor gold (10) 2 Nos of gas cylinder bottles. (11) 50 bags of paddy (12) 30 of duck & chicken (13) 2 Nos of colour fleet T.V. Set. (14) 1 Nos laptop and 1 Printer. (15) in cash Rs 3,50,000/- (Rupees three lakhs and fifty thousand) & (15) All others valuable item of properties, and in such unfortunate incident / mob violence. I have lost the following estimated cost amount Rs 40,00,000/- (Rupees forty lakhs) appx.

It is, therefore, requested you to kindly initiate and take necessary legal action against the matter according to law for the ends of justice.
