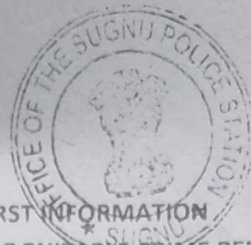

I, the undersigned have the honour to state that a large Numbers Kuki Militants groups stormed and burnt down my house and the Meitei inhabited areas of Serou Bazar on 3rd June 2023 at @10:20. In this incidents of violence we have lost the following assets of property
(1) House of Katcha with 3 rooms, (2) 3 Nos of Almirah and 2 Nos of double bed
(3) 3 meters of gold, (4) 2 Nos sofa sets, (5) 2 Nos of Bicycles, (6) 1 active
(7) 2 Nos of gas cylinder bottle, (8) 1 Freez Machine and 1 Washing Ma.
(9) 1 colour fleet T.V., (10) 1 Sewing tailor Machine, (11) All the valuable family garments, (12) in cash Rs 3,00,000/- (Rupees three lakhs) burnt down
(13) 4 Nos of Truck tyres, (14) large numbers of motor spare parts, (15) bags of paddy, (16) All valuable Kitchen utensil items, (17) 1 No of pig st along with 3 pigs, (18) 1 Toilet of Pakka construction, (19) valuable family furniture items, (20) 1 solar plate and its battery, (21) 30 Nos of duck etc
I have lost of all valuable items properties estimated cost approx Rs 25,00,000/- (Twenty five lakhs).

It is therefore, requested you to kindly initiate and take necessary actions against this matter according to law for the ends of justice.
