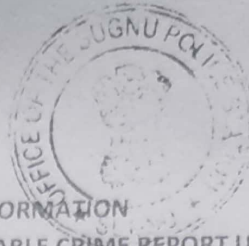

Sir,

I have the honour to state that on 28/05/2023 at about 03:30 am, my joined family house located at Serou Makha Leikai was burnt down by large numbers of unknown miscreants suspected to be Kuki militants and their supporters. In that incident, lots of my household properties were burnt into ashes. Particulars of the burnt items (1) Building house worth Rs. 30 lakh, (2) 2 Nos. of Fridge worth Rs.40 thousand (3) 7 Nos. of wooden bed worth Rs.200000/- (4) 5 Nos. of Gas cylinder and 2 Nos. of Gas stove worth Rs.20 thousand, (5) 2 Nos. of Washing machine worth Rs.40 thousand, (6) 3 Nos. of TV flat worth Rs.70 thousand, (7) 6 Nos. of Almirah worth Rs.300000/-, (8) 4 Nos. of Iron Godrej worth Rs.100000/-, (9) Clothing worth Rs.50 thousand, (10) Solar with battery worth Rs.30 thousand, (11) 2 Nos. of Stand Fan and 3 Nos. of ceiling Fan worth Rs.20 thousand, (12) Ornament worth Rs. 150000/-, (13) Sawn timber for building house worth Rs. 400000/-, (14) Grocery shop along with grocery items worth Rs. 3 lakh, (15) Dining table worth Rs.50 thousand and 6 Nos. of Sopha worth Rs.1 Lakh. Total value of all items is estimated to be Rs.50 lakh (Fifty lakh) approximately.

In this regard, I request you to take up necessary legal action at the earliest.
