I, the undersigned have the honour to state that a large number of Kuki Militants having with sophisticated deadly weapons stormed and burnt down my school building and other valuable school properties item at Siguu on 31 June 2023 at @ 9:00 pm. In that incident of mob violence my school building including furniture, laboratory materials, computers and other valuable properties have burnt down.

The lost materials items has been shown below:-

1. 12 Nos of Class Room building including office, laboratory
2. 250 Nos of desks and benches pairs
3. 40 Nos of Tables and chairs, 15 Nos of white boards
4. 4 Nos of Computer laptops,
5. 2 Nos of computer printers,
6. 3 Nos of computer Desk tops and CPU.
7. Huge Nos of school library valuable books,
8. Large Nos of school laboratory equipment items,
9. Important and valuable school documents,
10. 4 Nos. of wooden Almirahs and 4 Nos of iron gear
11. Numerous Sintex, buckets, brooms and water felt
12. One mike speaker, batteries and its electrical mat

13. 2 Nos of solar plates, 2 Nos of solar batteries
14. One inverter machine
15. 2 Nos of Washing Machines was looted.
16. 2 Nos of Freeze Machines was looted.
17. 10 sticks of Gold was looted
18. In Cash Rs 4,00,000/- (Rupees four lakhs) was also looted

In the above mentioned lost valuable properties items is total estimated cost Rs 2,20,00,000/- (Rupees two crores and, twenty lakhs) approximately.

It is therefore requested you to kindly initiate and take necessary legal actions against the matter according to law for the ends of justice.
