Kakching, Waihong District Chandel Manipur and that some armed radicals belonging to the Meetei/Meitei community broke open my rented/residential home and vandalized, looted and gutted/burnt down and all what is within and along with the house was lost to the said meetei/meitei armed radical groups illegal activities a total loss estimated to be at an amount of Rs. 69,00,000 Only.

Fortunately, me and my family managed to escaped from these criminals who even tried to kill or burn us alive, and now currently taking refuge at, Tuibong, CCPVR

Therefore I kindly request you to please take action in this matter and come up with positive solution. gal
