Subject: A complaint against (1) Chingakham Samananda Singh, aged about 45 years, s/o (L) Ch. Paona Singh of Keirao Wangkhem Mamang Leikai, Manipur. (2) Phijam Kamala Devi, aged about 42 years, w/o Ph. Nanao Singh of Keirao Wangkhem Awang Leikai, Manipur and their associates.

Sir,

We, the undersigned complainants, would like to lay down the following few lines for your kind perusal and necessary action.

That, on 29-06-2023 at around 7.00p.m. I, Hemanta (the complainant No.1) had an argument with Phijam Kamala Devi on the issue of non supply of Ujala Gas connection. The said Kamala Devi had taken an amount of Rs. 1300/- (rupees one thousand three hundred) only from me in connection with the said Gas connection but she returned back only Rs.1000/- (rupees one thousand) only to my wife. Chingakham Samananda Singh was also present at that time and place i.e., in front of Ritu Grocery Shop cum hotel at Keirao Wangkhem Makha Leikai. After hearing the argument the said Chingakham Samananda left the place in a hurry.

Then, after some argument I with my family members return back to our home. Thereafter, at around 8:00.p.m a mob led by Chingakham Samananda Singh illegally trespassed in my homestead land. He called out all my family members from my house. Thereafter, the mob started beating me and my brother and my son without assigning any valid reason by using deadly weapon. The said Samananda Singh also brought a gun and threatened to shot my family members. My whole family ran inside the house to save our lives.

Thereafter, the said mob started burning the my brother's car (A-Star) bearing Regd. No. MN04P3559, and also started dismantling the house by using deadly weapons. The said mob also partially burnt down my house.

The mob had also looted an amount of Rs.5,70,000/- (rupees five lakhs seventy thousand only) which was kept under my mattress. I had kept the said money for the construction of my house which is under construction. The accused persons also looted 1 gold chain, 2 rings altogether weighting 18 sans from P. Jiten Singh (complainant No.2). The accused persons also looted Rs.70,000/- (rupees seventy thousand) from the house of the complainant No.2 by breaking the main door.

The complainant No.2 was taken to JNIMS Hospital for treatment. The mob even inflicted injuries to the private part of the complainant No.2.

That, on 30-06-2023 the said Chingakham Samananda Singh by using loud speaker announced that the family of the complainant No.1 and 2 are vanished from the locality and their house will be dismantled. It is also further announced that the complainant No.1 & 2 can take out the belongings if any before 5.00p.m. of 30/06/2023 failing which the said belonging will also be destroyed. It is pertinent to mention here that the mother of the complainants who is also aged person also remain in the house and she fainted twice. Hence, we therefore request you to take necessary action against the said accused persons. We could not report the incident timely as we were waiting for negotiation with the accused party. However the accused side doesn't turn up. So we want to register an FIR regarding the said incident.
