Subject: - Request to arrest my younger sister named below for repeatedly committing theft at our house.

Sir,

I have the honour to report that my sister namely Ms. Ningaiwon Chiphang (25 Yrs) D/o (L) Shangreihao Chiphang of Kamphasom Ukhrul, Ukhrul District, Manipur has been committing theft in our house repeatedly since the last few years. The last incident of theft being on 15/07/2023 at around 4:00 p.m. at my house located at Khaivarentang, Ukhrul. It is note-worthy that after getting married, I settled at Khaivarentang, Ukhrul with my wife and children. On that day, she reportedly came to my house when I was away for work. She then broke the lock of the door and entered into the house. After entering the house, she broke the almirah and stole away Rs. 10,000/- (Ten thousand only) which I kept for emergency purposes. When I returned from work, I found the lock of the door and the almirah broken and the money amounting to Rs. 10,000/- was missing. When I enquired, I came to learn that my sister named above came at my house and stayed there for some time. When I enquired her, she said that she had spent all the money. In the past also, she had been stealing different amount of money on many instances. Our family tried to reason her through our own end but we failed to. So, at last, my family decided to lodge an FIR against her and lodge her in the jail for behavioral reformation.
