



Subject: - Report

Sir,

I have the honour to report that today i.e. on 07/08/2023 at around 8.00 am, I along with my team and a column of 39 Assam Rifles were carried out joint random frisking and checking at Lalpani Bazar along JT Road in view of ongoing clash in Manipur. While doing so, on the same day at around 11.45 am one Tata 407 vehicle bearing regd. No. AS 11 BC-9477 coming from Tripaimukh, Pherzwal District, Manipur side towards Jiribam Bazar was stopped for checking. On checking, 3 (three) persons were found inside the vehicle (including the driver) were detained for verification. On verification, they identified themselves as (1) Gias Uddin (24) yrs S/O. Ashik Ali of Makhan Nagar Punji, PO & PS- Jirighat & Dist.- Cachar, Assam, A/P- Digli, PO & PS- Jirighat & Dist.- Cachar, Assam (Driver of the vehicle) (2) Md. Fakarul Hussain (19) yrs S/O. Md. Toyub Uddin of Digili, PO & PS- Jirighat, Dist.- Cachar, Assam, (3) Ramijuddin Barbhuiya (43) yrs S/O. (L) Jid Ali Barbhuiya of Bhowmikpara, Jakuradhor, Borobekra, Jiribam, Manipur. It was suspected to have concealed some contraband items inside the vehicle and their belongings. Then I have given an option whether they would like to check in presence of an executive Magistrate or Gazatted officer or civil witnesses. In that, they offered to check in presence of Gazatted officer. Immediately, I have informed to Shri T. Inaobi Singh (MPS) SDPO, Jiribam regarding the matter. On arrival SDPO, Jiribam the vehicle was thoroughly checked in presence of 2 (two) civil witnesses namely (1) Jamal Hussain (51) yrs S/O. (L) Moskandar Ali of Lalpani Part-II, Jiribam, Manipur (2) Md. Mahmudul Hasan (35) yrs S/O. Md. Makram Ali of Lalpani Part-I, Jiribam. On checking, one Nylon Bazar bag was found on the back side of the driver's seat of the said vehicle. On opening of the said nylon bazar bag 2 (two) nos. of black plastic carry bags were found. Further, on opening the said plastic carry bags 13 (thirteen) nos. of soap caps suspected to have contained contraband brown sugar were detected. The 13 (thirteen) nos. of soap caps containing suspected to be brown sugar were taken out and marked as "A-1 to A-13" respectively. Subsequently, all the 13 (thirteen) nos. of soap caps were weighed (by using an electronic weighing machine) and found "A-1= 13.03 grams, A-2=12.91 grams, A-3=13.15 grams, A-4=12.24 grams, A-5=12.77 grams, A-6=11.98 grams A-7=12.76 grams, A-8=12.35 grams, A-9=13.40 grams, A-10=11.88 grams, A-11=13.48 grams, A-12= 13.95 grams, A-13= 13.00 grams (Total = 166.93 grams excluding the weight of the soap caps)".

Thereafter, all the soap caps containing suspected to be brown sugar i.e., "A-1 to A-13" were put inside a cartoon box and wrapped with plain white cloths and packed & sealed by using wax with a five rupee coin and marked as "P". The same along with one realme 7i mobile handset were seized from possession of **Ramijuddin Barbhuiya (43) yrs S/O. (L) Jid Ali Barbhuiya of Bhowmikpara, Jakuradhor, Borobekra, Jiribam, Manipur** on the same day at 12.20 pm by observing formalities. The involved Tata 407 vehicle bearing registration No. AS 11BC-9477, one Samsung Galaxy F23 5G mobile handset and one Samsung mobile Galaxy A03S mobile handset were also seized from the possession of **Gias Uddin (24) yrs S/O. Ashik Ali of Makhan Nagar Punji, PO & PS- Jirighat & Dist.- Cachar, Assam, A/P-**

Digli, PO & PS- Jirighat & Dist.- Cachar, Assam (Driver of the vehicle) and Md. Fakarul Hussain (19) yrs S/O. Md. Toyub Uddin of Digili, PO & PS- Jirighat, Dist.- Cachar, Assam on the same day at 12.25 pm and 12.30 pm respectively by observing formalities. Accordingly, the 3 (three) persons namely (1) Gias Uddin (24) yrs S/O. Ashik Ali of Makhan Nagar Punji, PO & PS- Jirighat & Dist.- Cachar, Assam, A/P- Digli, PO & PS- Jirighat & Dist.- Cachar, Assam (Driver of the vehicle) (2) Md. Fakarul Hussain (19) yrs S/O. Md. Toyub Uddin of Digili, PO & PS- Jirighat, Dist.- Cachar, Assam, (3) Ramijuddin Barbhuiya (43) yrs S/O. (L.) Jid Ali Barbhuiya of Bhowmikpara, Jakuradhor, Borobekra, Jiribam, Manipur were arrested on the same day at 12.35 pm, 12.40 pm & 12.45 pm respectively.

The seized items along with the arrested persons are handed over to you for taking further necessary action.
