

Subject:- FIR on physical assault on my brother Pastor LS Paul Hangmiat at Jiribam Police Station on 17th July, 2023.

Sir,

With reference to the cited subject, I would like to report that, on 17th July, 2023, my brother Pastor LS Paul Hangmi, resident of ST Chullouphai, Churachandpur (Lamka) while repairing his vehicle at a workshop in Jiribam town, a group of Meitei radical group, namely the Arambai Tenggol approached toward him. In a bid to save his life, he fled to the Jiribam police station.

However, unlike his hope and expectation, he was blindfolded and brutally beaten by black T-shirt wearing Meitei goons from 10:00 AM till 6:00 PM in the evening. Despite having undergone such ordeal, he could somehow manage to reach Lamka, where he is being treated at District hospital ICU Ward for serious injuries.

I therefore, requests you to kindly take all necessary legal actions and procedures so as to ensure the culprits are booked and punished according to the relevant law (s) of the land, thereby deliver justice to the innocent victim.

Looking forward to your speedy initiatives so that rule of law is prevailed.
