Today i.e. 04/05/2023 at @ 10:34 pm a huge number of unknown persons (more than 300 approx.) having with sharp weapons and guns came at Yaingangpokpi PS and demanded to give arms and ammunition. Related the matters, the police personnel and the crowd had unwanted incident between the police and the crowd. The police warned them to go back and not to cross the station's gate. Then, they started to break the station's gate and also threw stones, stick and fired gun at the police side. After that, the police personnel fired tear gas to control the mob but it was useless. Then, the police fired live rounds and dispersed them from the police station.

Hence a suo-motto case was registered under FIR / No. 05(05)2023 YPI-PS, U/S 147/148/149 IPC have registered at the PS.
