Today i.e. 28/05/2023 at around @ 03:10 am, a large numbers of Kuki youth and suspected to be armed Kuki militants by using sophisticated weapons (like AK Rifles, M-16 Rifles etc. fire several rounds in & around Yaingangpokpi PS Jurisdiction i.e. Gwatabi village, Sanasabi village, Molnoljang village, Urangpat village, Semol village, Sangral village, Tulchin village & Phalmol village. The militants also fire to the security personnel side which is station at Yaingangpokpi PS from Molnemjang village and Gwatabi village side. On the incident four (4) civilian of Gwatabi village, were injured. On that the Police personnel of YPI-PS & team of Addl.SP (Traffic) I/E were blank fired several rounds of AK, SLR, INSAS, 303 Rifles & 9mm to defense and control the situation. The BSF personnel also firing several round in blank to control the situation. The exchange of firing Kuki militants and security forces took two/three hours.

Unfortunately around 40/45 houses including two community hall of Meitai community of Gwatabi village were burnt into ash by the suspected Kuki armed militants.

In this regard the OC/YPI-PS registered a suo-motto case under FIR No. 07(05)2023 YPI-PS, U/S : 147/148/188/447/436/427/307/338/120-B/400 -IPC & 25(1-C) A. Act have been registered.
