Today I.e. 28/05/2023 at around @ 03:50 am received a reliable information that on the same day at around 3.10 am a large numbers of Kuki along with suspected Kuki armed militants came down from nearby foothill Simol and fired several rounds of automatic weapons at Sanasabi Awang Leikai & burnt down one house of Meitel community. The suspected Kuki arms militant were also firing to the security forces (BSF) side. On that incident one team of BSF which is deployed at Sanasabi Mayai Leikai and one team of Yaingangpokpi PS led by ASI. A Suresh Singh deployed at Thamnapokpi Awang leikai blank fired several rounds to control the situation so as not to happen any other unwanted incidents. The exchange of firing took around one and half hours.

In this regard the OC/YPI-PS registered a suo-motto case under FIR / No. 08(05)2023 YPI-PS, U/S: 147/148/188/447/436/427/307/120-B/400 -IPC & 25(1-C) A. Act. have been registered.
