manimore node Today i.e. 20/05/2088 at assund @ 04/30 are received a reliable information that on the same day at around 3.20 am some Kuki community youth and suspected to be some Kuki armed militants, using automatic weapons fired to the Santikhongbal village area & burnt down one house & one Cattle shed at around. And also the armed militant fire numbers of live round to the security personnel of BSF. On that the security personnel of BSF fired several rounds & control the situation. The armed militants escape the place by taking advantage darkness of the night. On the same day i.e. 25/05/2023 at around @ 06:30 am a mob numbering about 500/600 men & women from the Meltel community came to village of Tulchin, Phalmol and Sangran, Sangran Khunou village & burnt down some houses of Kuki community. On that one combined team of Adit. SP/Traffic-I/E, one team of Yaingangpokpi PS, CDO-I/E, one team of Lamiai PS and one team BSF rush to the area & fire mob bomb, blank fire to control the situation. Unfortunately the Kuki militant also fired by using automatic arms to the security forces and to the civilian. On that incident one security personnel & seven (7) civilian were injured. The injured persons were evacuated to JNIMS hospital for medical treatment. The exchange firing took till late night of 28/5/2023.
