Respected Sir,

I have the honour to report you that on 29/05/2023 at around 9:00 pm, a group of unknown persons suspected to be Kuki militants numbering around 50 people holding with sophisticated weapons have enter our Laikhong village , PS- Thoubal Dam, District - Imphal East, Manipur and completely burnt 48 houses including Laikhong Youth Club, Laikhong village Godown and Office of Village Level Federation Laikhong , that include asset and properties that left our villagers homeless. The approximate Value of the burnt items is about Rs. 3 crores.

I, request your good self to intervene in this matter urgently and protect our property and our life from any further burnt, loss or damage. You are also requested to register an FIR and submit the computation of the loss to our property mentioned here, to any appropriate body of the state government to grant us the compensation that we need to rebuild our lives.
