

Subject: Reporting the indiscriminate firing attempting to murder, destruction, arson and burning/torching of my house located at Gwaltabl village, Imphal East District and all my movable and immovable property by unlawful Chin-Kuki armed terrorists on the 28th May, 2023.

Sir,

With due regards I, the undersigned, a bona-fide resident of Gwaltabl village, Imphal East District pray to report the following facts for your kind acknowledgement and necessary lodging/filing of an F.I.R. against the indiscriminate firing of sophisticated assault rifles attempting to murder me and my family members, destruction, arson and burning/torching of my house and all my movable and immovable property worth about Rs.38,02,800/- under the guidance of Indigenous Tribal Leader Forum (ITLF), Indigenous Tribal Youth Forum (ITYF) and unlawful Chin-Kuki armed terrorists which is coming out from the Senai Camp.(SoO Camp.) located at Lokchao Hungta Village at around 3:00 am midnight; of the 28th May, 2023; in spite of a joint meeting with the village chiefs of the neighbouring Chin-Kuki villages on the 4th May, 2023 and mutual agreement of non-provocation or assault to one another, thereby requesting to take immediate action to arrest the culprit, punish the perpetrator in accordance with the law of the land and make necessary arrangements to compensate the loss of life & property.
