Subject: Complaint against the attack on Believer Eastern Church and vandalising and burning of its Church building and pastor's quarter located at Laikhong Village, Imphal East District, P.S. ~~T.B.L~~ - DAM - PS.

Respected Sir/Madam,

I am writing to file a police complaint on behalf of the Believer Eastern Church, located at Laikhong Village, Imphal East District, Manipur.

On May 28, 2023, at around 3.30 pm, a group of people came to the church premises and attacked the church building and vandalized and destroyed the Church Building and properties of the church.

The mob entered the holy sanctuary of the church and destroyed the holy pulpit and musical instruments used in worship. They burnt the furniture and a part of the church building and pastor's quarter, causing damage worth Rs 5 Lakhs.

We request your good self to intervene in this matter and urgently to take the legal necessary action against the culprits and protect our land and property and our life and limb from any further loss or damage. You are also requested to file an FIR and submit the computation of the loss to our property mentioned here, to any appropriate body of the state government to grant us the compensation that we need to rebuild the Church Building, Parsonage and our lives.
