SUB - LODGING AN FIR.

SIR,

At around 0305 hrs, a firing sound was heard near the camp. ASI Umed Singh reported to Coy Comdr and blown emergency whistle and Coy came in stand to. Then QRT team lead by Coy Comdr Sh Atul, AC along with 01 SO and 10 ORS in two vehicles went towards Santikhongbal village. However at the same time report given by Sh Bijoy Kumar, ASP Manipur police that two house has been torched in Gwaltabi village. Then Coy Comdr along with QRT left towards Gwaltabi village. While going the toward Gwaltabi QRT party debarked the vehicle near the Gwaltabi village and while they were on foot moving towards Gwaltabi aimed fire from appx 40 mtr fired towards QRT party from Molneljang village then the QRT took position in the field and shot two warning rounds in the air. However the fire continued with intention to inflict damage to BSF party. Then in retaliation and self-defense Coy Comdr Sh Atul, AC, CT Md Imran, Ct Gohe Rajesh and CT Sanjib Nath fired single shot rounds (total 44 rounds) in which two armed men have been shot and taken back towards the village. The armed men who were shot were also taken by them. The QRT party stopped fire and tactically reached to village Gwaltabi and successfully stopped burning of houses.

At around 0315 one more platoon of E- Coy, , Ex- 119 Bn BSF under Adhoc M&C B3 deployed at village Sanasabi led by SI P K Chaudhary along with 01 SO and 14 ORs are attacked from the side of Simol village located at approx 350 Mtr North-West to Sanasabi Village. Here a crowd of more than 100 people along with arms including automatic weapon started to fire on BSF party and moved towards Sanasabi village through fields, by taking cover of darkness with intention to burn houses in Sansasabi village. Party Comdr SI P K Choudhary immediately gave command to fire 04 warning shot and informed Coy Comdr on radio set. Coy Comdr gave order to hold the position and counter fire immediately in self-defense and to protect the village while causing minimum injury. Still the armed man did not stop even after the warning fire and continued to fire and keep moving towards Sanasabi and started to throw petrol bomb towards village. When armed men were around approx. 100 mtrs SI P K Chaudhary gave fire order to platoon then CT P K Kheti, CT P B Kajale, CT Motinur Islam, No HC Inder Kumar Verma, HC Amar Singh Pikra, CT Praveen fired 163 rounds. In which five armed men were shot and other ran towards the Simol village, the armed men who were shot also taken by them.

At about 0320 hrs approx. 50 men, some of them with automatics weapon came towards from hill side of Twichin village and started fire towards BSF camp with intention to burn the BSF camp and village houses near the camp. To stop them Asi Umed Singh commanded to Ct Dharmendra Kumar to fire 5 warning rounds in air and informed Coy Comdr on set and Coy Comdr instructed him to fire in self-defense to save the camp and village. However armed men continued to fire which hit perimeter of camp and started to throw petrol bomb in which a cattle shed located approx. 100 mtrs from the camp caught fire. Then

At about 281955 one platoon led by Insp Abhay kumar Singh which was deployed at Sanasabi, were attacked by armed men from the side of Simol village. Insp Abhay kumar Singh commanded to Mortar man to fire a one illumination bomb to confirm the situation and fired two warning shot. Still they continued to fire from automatic weapon from Simol village side and tried to come towards Sanasabi village. At this point Insp Abhay kr Singh ordered the platoon to fire in self-defense and protect the village in which HC Harish Sharma, CT Adarsh, CT Sanjeev Kumar, CT Vishal Singh, 63 rounds fired and one illumination bomb fired at about at 2215 to check any suspicious movement.

Again at about 290030 hrs from the Simol village armed men started to fire BSF party. Insp Abhay Kr Singh command to Mortar man to fire a one illumination bomb to confirm the situation and fired two warning shots. However they continued to fire from Simol village side. Insp Abhay kr Singh ordered the platoon to fire in self-defense and protect the village in which CT Manpreet Singh, CT MD Badruddin, CT Sudhakar Swain, CT Anil Sharma, 62 rounds fired and one illumination bomb fired at about at 0215 hrs, in which 5.56mm INSAS - 440 Rounds, 7.62 AK-47 - 18 Rounds and 51mm Illumination bomb - 04 fired. To EFC recovered - 185 Nos 5.56mm INSAS.
