Subject : Report

Sir,

I have the honour to state that, on 05-05-2023 at around 02:30 pm some unknown miscreants belonging to Meitei Youths Organisation of Arambai Tenggol, World Meitei Council (WMC), Meitei Leepun and Kangleipak Kanba Lup (KKL), numbering about 500-600 members carrying sophisticated weapon like AK Rifles, SLR and .303 Rifles forcefully entered my village, Bongbal kholen, PO- Yairipok, PS- Maphoudam PS, Island Sub-Division Kangpokpi District Manipur, having 135 houses, after looting all the valuable household items, has been burnt down to ashes leaving us homeless. Apart from the house some important building like Church, School, Community Hall, Anganwadi Centre, Post Office, Primary Sub-Centre building, Marketshed, Granaries, village Library, Church Generator (Kiloskar value 5.20 Lakhs) and Youth club Office were also burnt down.

The approximate value of lost properties is estimated at about Rs.70-120 Crores.

It is, therefore, requested to kindly booked the culprits and take necessary legal action according to law.
