Sir,

I have the honour to state that, on 30-05-2023 at around 07:00 am some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meitei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 1500-2000 persons carrying sophisticated weapons like AK, SLR, INSAS and .303 rifles forcefully entered our village, Saichang village, Island Sub-Division, Kangpokpi District, Manipur about 45 Km East from Saikul-PS. They vandalised and burnt my house to ashes leaving us homeless. The approximate value of properties destroyed is calculated at about Rs. 80,00,000/- (eighty lakhs).

In addition to, my husband namely, Paohao Khongsai aged about 33 yrs was also killed by them. He was JCB driver by profession and survived by me and our three daughters. Amidst of fear and tension, I have buried him in our village on the same day.

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.

Brief fact of the case:

On 01/06/2023 at 3:40 pm the complainant namely NgahneihoiKhongsai(26)yrs w/o PaohaoKhongsai of Saichang Village,Kangpokpi District reported with the OC- Saikul Police Station stating that on 30/05/2023 at around 7:00 am some unknown miscreants suspected to be a members of Meitei Youth organization Meitei Leepun, KangleipakKanbaLup(KKL), Arambai Tenggol and World Meitei Council (WMC) and Schedule Tribe Demand Committee(STDC)numbering about 1500-2000 persons carrying sophiscated weapons like AK,SLR, INSAS and .303 rifles forcefully entered their village, Saichang village, Island Sub-Division Kangpokpi District, Manipur about 45 km East from Saikul PS. They vandalized and burnt her house to ashes house leaving them homeless. The approximate value of properties destroyed is calculated at about Rs.80,00,000(Eighty lakhs). In addition to, her husband namely PaohaoKhongsai aged about 33 yrs was also killed by them. He was JCB driver by profession and survived by her and their three daughters. Amidst of fear and tension, she have buried him in their village on the same day. Hence the case.

Investigation:

During the course of investigation, the OC TBL DAM PS have taken a regular case under FIR No. 106(6)2023 TBL DAM PS U/S 153 A/302/307/427/436/448/34 IPC & 25(1-C)A.Act from the corresponding case of FIR No. 0(144)(6)2023 SKL PS U/S 153 A/302/307/427/436/448/34 IPC & 25(1-C)A.Act taken by OC/Saikul PS. Visited the place of occurrence i.e., at Saichang village, Island Sub-Division Kangpokpi District. Further efforts were tried to locate or identify the place where the dead body of (L) Paohao Khongsai of Saichang Village, Kangpokpi District was buried for further required formalities but could not, as there was no any localities present. Also the complainant could not be contacted as the ongoing conflict in between Meitei and Kuki tribe.

Investigation is under process.
