On dated 15/06/23. At about 2100 hrs a patrolling party led by Insp Abhay Kumar Singh with 01 so and 06 ORS (Total 8) left the BSF Camp. When were present near Village Sabungkhok Khunou (Meitei Village) at 2120 The patrolling party heard multiple shots and saw a house burning in the fields near brick kiln owned by Meitel community (approx. 350 meter) from their position and approx 800 mtr from the BSF Camp. Insp Abhay Kumar Singh along with his party rushed to Village Sabungkhok Khunou and informed Coy Comdr telephonically. Coy Comdr instructed him to fire warning shots in air to scare away miscreants. Then Coy Comdr along with QRT party reached the village and joined the patrolling party. Then they moved towards the burning house which was located in the field using fire and move technique and put out fire burning in house and saved the brick kiln and adjacent houses.
