Sir,

With due respect I humbly request you to file an FIR as our house and shop (Dukan) located at Gwalatabi Mamangleikai have been burnt down and looted all the movable items along with domestic animals by armed Kuki militants which is coming out from Senai Camp (SoO Camp) located at Lokchao Hungta village and the volunteers of Indigenous Tribal Leaders Forum (ITLF) and Indigenous Tribal Youth Forum (ITYF) in the early morning of 28th Sunday, 2023 at around 3.30 am. As a result of which all the household items and Shop items were totally burned down and looted. It has been done against the law, which violent people's rights of India.

So, it will be very thankful if you file this FIR against them.
