Sir,

I have the honour to state that, on 06-05-2023 at around 07:30 am some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 1000 persons carrying sophisticated weapons like AK, SLR, INSAS and .303 rifles forcefully entered our village, Molkonbung village, Island Sub-Division, Kangpokpi District, Manipur about 80 Km East from Saikul-PS. After vandalising and looting all the moveable properties they burnt down my house to ashes alongwith one Scooty bearing Regd. No. MN01AF 6281 leaving us homeless. The approximate value of lost property is calculated at about Rs. 25,00,000/-(twenty five lakhs).

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
