Subject: Complaint Against unknown people. The complaint be registered as F.I.R

Respected sir,

This is to inform you that under the guidance CSIR- NEIST Jorhat (Government of India) we are constructing joint research centre for cultivation and extraction facility for medicinal plant at village K.Nungmanbi, Island Sub Division, District Kangpokpi, Manipur. For the said purpose, the Government of Manipur had issued license for manufacturing and sale of medicine derived from medicinal plant, and also to carry out research on medicinal plant at Manipur.

It is hereby brought to your kind attention that numbers of incident have taken place in the State of Manipur. The same has let to numerous damages of properties and human losses across the state. It is with utter pain we inform you that Indica Nutraceuticals was no exceptional to the same and after the start of this violence on 8th and 9th May all the people of our security agency left the place to save their life.

It was only on 10th May 2023 that a local person informed us that some unknown people forcefully entered our site of Indica nutraceutical and burned the entire office in ashes along with the wallet (where the cultivated crops of were kept) by the excise department. The entire cultivated crops of a year got burned in the flames. Further some other assets of the company on the sites were also damaged. Such as a JCB-picoline eviction machine of a vendor working on the site was also burned.

It is utter most important to mention herein that in the fire put by the unknown people, even the entire recording area was burned. The same led to the non-recovery of the recording of CCTV Cameras. The Hard Disk is in such a condition that nothing can be recovered from the same. The entire incident led to a great financial loses to the Indica nutraceuticals.

That for your kind perusal the photographs of the site showcasing the damages caused at the site are herein annexed along with the present application. The same are self-explanatory.

That due to curfew in the entire state we were not able to inform you the same. It is hereby requested to you, to please register a FIR against the said unknown people and trace them and take necessary action against them in accordance with law. We request you please file the FIR under section 425, Section 268 of IPC, Section 378 and Section 445.
