Then a scuffle ensured, the army open fire upon the Meitei youths and meirapaibis present there. In that a youth sustained bullet injury on his hand and evacuated to Raj Medicity for medical treatment.

Hence a suo motto case was registered under case FIR 112(6)203 TBL DAM PS U/S 147/149/353/400/34 IPC & 25(1-C) A for further investigation.
