**LODGING OF FIR : DATED 28 JUN 2023**

1. On the morning of 24 June 2023, based on inputs of presence of likely UG cadres in village Itham (06 KM East of Andro) in Imphal East (An area notified under the provisions of AFSPA), an Operation was conducted by Indian Army Columns to apprehend the suspected cadres. At approx 1030 Hrs, the said Columns, under the provisions of AFSPA cordoned the target house harbouring the cadres inside the house of Shri Jadu Mani (aged between 40-45 Years). At 1100 Hrs the same was informed to OC Mapahu after which police representatives led by DSP Sudheer and OC Maphau PS Mr Mohammed Umar Alam reached the location wherein after entry was made in the suspected house.
2. Subsequently, a total of 12 KYKL Cadres (a terrorist organisation in terms of Section 35 of UAPA, 1967, listed in the First Schedule of the Act) led by Self-Styled Lt Col Moirangthem Tamba alias Uttam (Proclaimed Offender wanted by the National Investigative Agency) were found in possession of large cache of weapons and ammunitions, inside the house by the columns and the Police. These weapons were also inspected by the Police reps. Photographic evidence of the said suspects and recovery is enclosed. On being asked, SS Lt Col Moirangthem Tamba alias Uttam volunteered that the said cadres infiltrated from Myanmar and after crossing the Indo Myanmar Border, they had been travelling for the last 5 days with the common object and criminal intention to burn Maphou village, in Imphal East district.
3. In the meantime, the local MLA Mr Thounaojam Shyamkumar (constituency Andro) reached the location without any intimation and started obstructing to deter the operation and threatened the Army Columns to unlawfully release the apprehended UG cadres and weapons. Mr Thounaojam Shyamkumar warned the Army column of dire consequences incl immediate attack by the violent mob which had been mobilised around the house on his behest. Within a short period of time, on the clear instructions of the said MLA, the house was surrounded by 1200-1500 riotous mob comprising of aggressively agitating ladies identifying themselves as



'Meira Paibis'. In the meanwhile, the said rioters had already blocked all entry and exit routes to the village, and allowed no Army Column to move thereby wrongfully restraining and confining the personnel.

4. Simultaneously, the police was being requested by the Army to forthwith send heavy Police column and Rapid Action Force to take control of the rioters. The Army also requested the MLA Mr Thounaojam Shyamkumar to cooperate and let the police take custody of the KYKL cadres as per existing legal procedures, however, the MLA reiterated his threats to the Army personnel and continued protecting the suspected members of the Terrorist org.

5. At about 1330 Hrs , Mr Shyamkumar along with DSP Sudheer and OIC Maphou PS, Mr Mohammad Umar Alam slipped out of the location and was not seen thereafter. Before departing from the incident location, the MLA directed a riotous mob of 300-400 Meira Paibis to barge into the house and also surround the Army personnel were guarding the suspected terrorists. The rioting Meira Paibis demanded release of the KYKL militants who had entered from Myanmar as well as to hand over of the recovered evidence and weapons. The Army requested not to obstruct the Army personnel from carrying out their bonafide military duty and let the UG be taken in Police Custody for investigation in accordance with law, however, they refused to do so and tried to assault and cause hurt to the Army personnel including attempt to snatch the personal weapons of the Army personnel. During the ongoing commotion, rioters including Meira Paibis, taking advantage of restraint shown by Army Personnel against women, managed to rob some of the confiscated weapons with clear intent and motive cause disappearance of evidence recovered in form of weapons. Furthermore, the riotous situation was created with the assault by Meira Paibis to facilitate the escape of the UG cadres from lawful custody with intent of causing disappearance of evidence and screening the suspected offenders accused of serious offences incl capital offences as well as under UAPA, IPC etc.

6. Mr Thounaojam Shyamkumar orchestrated the entire situation leading to the escape of the suspected terrorists and ensured that all the exit routes from the village were either blocked or dug out by the rioters with the clear intent of wrongfully restraining and confining the armed forces personnel, thus causing disappearance of offenders and evidence.

7. List of items seized during the operation are mentioned below. The seizure memo is attached:-

8. Details of UG cadres along with the photographic evidence of the incident spot are enclosed along with the certificate under section 65B of the Indian Evidence Act, 1872. The said cadres be immediately identified and arrested to prevent them from giving affect to their criminal intent and conspiracy. The said suspects may also be proceeded with for being in possession (unlawful) of Arms and Amn, the aforesaid escape from lawful custody (Sec 223, 224 IPC), and for existing FIRs, if any .

9. Further, it is requested that FIR may be lodged against the MLA Mr Thounaojam Shyamkumar for the following offences : -

- (a) Obstructing Public Servants from discharge of their lawful duty in suppressing and dispersing unlawful assembly contrary to Sec 353 of the IPC.
- (b) Obstructing Public Servants in apprehending the most wanted KYKL (An association that has been notified as unlawful by the Central Government under Section 3 of Unlawful Activities Prevention Act 1967 vide notification dated 13 November 2018) cadre member SS Lt Col Moinangthem Tamba alias Uttam, alongwith other 11 members and unlawfully resisting their arrest and permitting escape, contrary to Sec 201, 223, 224 and 225 of the IPC.
- (c) Assisting/ Aiding escape of the KYKL cadres (An association that has been notified as unlawful by the Central Government under Section 3 of Unlawful Activities Prevention Act 1967 vide notification dated 13 November 2018) from the lawful custody of Indian Army who were performing bonafide military duty in AFSPA and Aid to Civil Authorities.



(d) Obstructing Public Servants in confiscating recovered weapons found in possession of the KYKL cadres and causing disappearance of evidence and screening of offenders, contrary to Sec 201 of the IPC.

(e) Criminal Intimidation, Assault and use of Criminal Force against Public Servants who were discharging their Public duty in Aid to civil Authorities contrary to the aforementioned provn incl Sec 34, 120, 503, 504, 505, 506, 332 of the IPC.

(f) Instigating and abetting the Unlawful Assembly of rioting Meira Paibis and locals in order to obstruct the Army in performance of their lawful duty on 24 June 2023 contrary to the aforementioned provn incl Sec 147, 503, 504, 505 and 506 of the IPC.

10. FIR against Shri Jadumani, resident of village Itham, Imphal (East) may also be lodged for the following offences : -

(a) Voluntarily harboring 12 x KYKL UG cadre (an association that has been notified as unlawful by the Central Government under Section 3 of Unlawful Activities Prevention Act 1967 vide notification dated 13 November 2018) at his house at village Itham, contrary to Sec 19 of UAPA.

(b) Assisting/ aiding escape of the KYKL cadres (an association that has been notified as unlawful by the Central Government under Section 3 of Unlawful Activities Prevention Act 1967 vide notification dated 13 November 2018) from the lawful custody of Indian Army personnel who were performing bonafide Military duty in terms of AFSPA and Aid to Civil Authorities contrary to Sec 201, 223, 224, and 225 of the IPC.

11. FIR against unknown/ unidentified rioting Meirra Paibis and other rioters may also be lodged for the following offences : -

(a) Obstructing Public Servants from discharge of their official duty in suppressing and dispersing unlawful assembly contrary to the aforementioned provn incl Sec 353, 503, 504, 505 and 506 of the IPC .

(b) Obstructing the Public Servants in apprehending the most wanted KYKL cadre (An association that has been notified as unlawful by the Central Govt under Section 3 of Unlawful Activities Prevention Act 1967 vide notification dated 13 Nov 2018) member (SS Lt Col Moinangthem Tamba alias Uttam) alongwith other 11 members and unlawfully resisting their arrest, contrary to Sec 201, 223, 224, and 225 of the IPC.



(c) Assisting/ aiding escape of the KYKL cadres (an association that has been notified as unlawful by the Central Government under Section 3 of Unlawful Activities Prevention Act 1967 vide notification dated 13 Nov 2018) from the lawful custody of Indian Army while performing bonafide Military duty in Aid to Civil Authorities, contrary to Sec 201, 223, 224, and 225 of the IPC.

(d) Obstructing Public Servants while confiscating recovered weapons found in possession of KYKL cadres contrary to Sec 201 and 353 of the IPC.

(e) Use of Assault and Criminal Force against Public Servants discharging Public duty in Aid to Civil Authorities contrary to Sec 34, 120, 350, 353 and 332 of the IPC.

(f) Instigating and abetting the Unlawful Assembly of rioting Meira Paibis and locals to obstruct the Army in performance of their lawful duty on 24 June 2023 contrary to Sec 34, 120, 353, 505 and 147 of the IPC.

(g) Intentionally attempting to snatch weapons from Indian Army personnel who were performing bonafide Military duty in Aid to Civil Authorities contrary to Sec 201, 223, 224 and 225 of the IPC.

(h) Intentionally and dishonestly taking away confiscated illegal weapons of the KYKL cadres without the consent of Indian Army personnel who were in lawful custody of the weapons with a clear intent to cause injury/ inflict hurt by taking advantage of restraint shown by Army Personnel against women.

12. The Hon'ble Supreme Court in **Lalita Kumari vs Govt of UP (MANU/SC/1166/2013)** has held "It is mandatory to file the FIR u/s 154 of the Code if the information discloses the commission of a cognizable crime and no preliminary investigation is permissible in such a case". In deference to the Hon'ble SC ruling, you are requested to register a First Information Report against the above mentioned persons.
