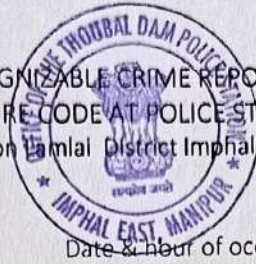

- (ii) Lourembam Open Singh, (Ex-Member of Tumukhong Moirangpurel Gram Panchayat) aged about 40 years, S/o. Lourembam Pakchao;
- (iii) Kshetrimayum Tharik Devi, aged about 48 years, W/o Ksh. Kulachandra Singh;
- (iv) Sadokpam Saphabi Devi, aged about 40 years, W/o. S. Chaoba Meitei,
- (v) Moirangthem Ngoubi Devi, aged about 37 years, W/o M. Inaoton Meetei;
- (vi) Loitongbam Mitlu Devi, aged about 34 years. W/o L. Dona Meitei.
- (vii) Sanasam Bilashini, aged about 53 years W/o Sanasam Manglemjao;
- (viii) Sagolshem Indrani, aged about 38 years, W/o. Sagolsjem Sunil;
- (ix) Oinam Icha, aged about 39 years, W/o. Oinam Dhamen;
- (x) Sanasam Chaobi, aged about 51 years, Sanasam Iboyaima;

All resident of Tumukhong, Imphal East, Manipur.

(xi) Mikel Singh (Police Personnel), aged about 34 years, S/o. Unknown, posted at Tumukhong Police Station, near Maphou Dam along with two other Police Personnel who were posted at the aforesaid Police Station, whose name is not known by the Complainant.

Dear Sir,

With due respect and humble submission, we bring forward for your kind consideration and favourable action, stating herein below: -

1. That, we are permanent resident of Thangjingpokpi Lamkhair, near Tumukhong bridge. Our residence is located in the main road which leads toward Maphou Dam, therefore, for the purpose of earning our livelihood we have opened a grocery shop at our residence. It is pertinent to mention herein that our residence is a semi-pucca house with tinted roof (CGI roof), consisting of 4 (four) rooms inclusive of grocery shop.

2. That, on 02/06/2023 around 9:00 a.m, 3 (three) Police Personnel led by one Mikel Singh came to our residence situated at Thangjingpokpi Lamkhair near Tumukhong, who were posted at Maphou Dam Police Station, near Tumukhong village, arrested one of the Complainant i.e Laishram Ingocha alleging that he is the informer of Kuki and had assisted the Kuki in supplying edible items. It is submitted that on the aforesaid day, the 3 (three) police personnel came in white colour Maruti Gypsy equipped with arms.

3. That, on the aforesaid day i.e 02/06/2023, the 3 (three) Police Personnel knock the door of the Complainants residence and on opening the door,

one of the Complainant namely Laishram Ingocha was tried to hit on his head by the Police Personnel however, it was missed. Thereafter, one of the Complainant namely Laishram Ingocha was dragged from our residence to the main road and was beaten mercilessly by wooden stick. At the relevant point of time one of the Complainant namely Moirangthem (N) Laishram (O) Anita was talking to her son Laishram Thoithoiba through mobile phone.

4. That, after beating one of the Complainant i.e Laishram Ingocha on the main road by the Police Personnel, the Complainant i.e Laishram Ingocha was handed over to some of the person who are resident of Tumukhong. After one of the Complainant i.e Laishram Ingocha was arrested by the Police Personnel, the other Complainant namely Moirangthem (N) Laishram (O) Anita went to Tangkhul village namely Thangjingpokpi in order to seek assistance from the Meira Paibi's Chief and Village Chief, since one of the Complainant i.e Laishram Ingocha was arrested by the Police Personnel posted at Maphou Dam Police Station.

5. That, after intimating the Meira Paibi Chief and village chief of Thangjingpokpi Village, one of the Complainant namely Moirangthem (N) Laishram (O) Anita came to our residence and on the way to our residence, many women folks namely Sanasam Chaobi, Sanasam Bilashini, Sagolshem Indrani, Oinal Icha, Kshetrimayum Tharik Devi, Sadokpam Saphabi Devi, Moirangthem Ngoubi Devi, Loitongbam Mitlu Devi along with other women folks, who are resident of Tumukhong Village whose names the Complainants did not remember. On the way to our residence near the bridge of Tumukhong, Sanasam Chaobi tried to hit one of the Complainant namely Moirangthem (N) Laishram (O) Anita on her head by a wooden stick however, one of the Complainant was saved by our daughter namely

Laishram Premeshwori by snatching the wooden stick. Thereafter one of the Complainant Moirangthem (N) Laishram (O) Anita was taken to one of the school, located at Tumukhong Village by the women folks of Tumukhong Village.

6. That, after taking one of the Complainant Moirangthem (N) Laishram (O) Anita to one of the school located at Tumukhong Village, her hand was tied by a rope on her back side and thereafter her eyes had been covered by a cloth. After her eyes had been covered by cloth, she was beaten up mostly by Sanasam Chaobi, Sanasam Bilashini, Sagolshem Indrani, Oinal Icha including other women folks, alleging that, she is the spy of kuki and had been passing information to the Kuki in the prevailing situation. Not only that the Complainants were also alleged that, the Complainants were supplying edible items to the Kuki.

7. That, after beating the complainant namely Moirangthem (N) Laishram (O) Anita by the women folks of Tumukhong Village, one person namely Lourembam Open Secretary of Tumukhong Village Authority and Ex-Member of Tumukhong Moirangpurel Itham Gram Panchayat, came and took right thumb impression of the complainant namely miorangthem (N) Laishram (O) Anita forcefully on a blank paper. In addition to that, the mobile handset of the Complainant Laishram (O) Anita was taken by the Villagers of Tumukhong Village.

8. That, prior to 5 days of the incident which occurred on 02/06/2023, 3 (three) police personnel posted at Maphou Dam Police station was running after and trying to catch a Cock of the Complainants. When the cock ran into the house of the present complainants, the police personnel ask for the

cock and thereafter the present complainants informed that the cock was in their possession and the cock belongs to them. There was some exchange of hot words between the Complainants and the three Police Personnel, since the police personnel was trying to catch the cock of the Complainants.

9. That, after beating one of the Complainant namely Laishram Ingocha by the Police Personnel, he was left on the main road, therefore, Laishram Ingocha, who is one of the Complainant returned to our residence. On returning to our residence, Laishram Ingocha, who is one of the Complainant, saw a JCB Excavator, being driven by Sadokpam Sanatomba, S/o. Sadokpam Chaoba dismantling the residence of the Complainants. That, the dismantling of the residence of the Complainants was made at the behest of the villagers of Tumukhong Village.

10. That, after dismantling the residence of the Complainants, the mob i.e villagers of Thumukhong Village took away three Money Box popularly known as Bakshi containing Rs. 3,50,000/- (Rupees three lakh and fifty thousand) only including one gold necklace of 11 san, and 5 ring made of gold of one san each. In addition to that, the mob took away all the items from the Complainants shops including grocery item valued of about Rs. 60,000/- (Rupees sixty thousand) only.

11. That, apart from the grocery items and items of the Complainants shop, the mob broke and ruined the washing Machine, T.V Set, Refrigerator, Wooden Almira having two door, Stand fan, two Gas Cylinders filled with full LPG, one double bed, one medium Bed, two single bed, one large dining table, One Side-table, one Fiyan khok was destroyed. The mob also took

away all the new cloths and kitchen items costing around Rs. 1,00,000/- (one lakh) only.

12. That, on account of the beating by the Police Personnel as well as by the women folks to the Complainants, the Complainants had suffered grievous injury and was treated at Advanced Hospital, Mahabali as an Out Patient Department. The acts of the accused persons are not pardonable and they should be punished as per the law of the land.

In view of the facts and circumstances of the case, it is therefore most respectfully prayed that, FIR may be registered against all the above named accused persons and they may be prosecuted/punished as per the law of the land, in the interest of justice.
