- Subject:- A complaint for taking penal action to unknown Kuki Militants for causing mischief caused by fire of my farm houses two in number, located at Sanasabi Village (071-Laikot), Imphal East District, Manipur.

Sir,

I have the honour to lay this information to register an FIR against unknown armed Kuki Militants who set ablaze my two farm houses (one pucca and one kaccha) at around 3:30 am of 28-05-2023, located at Sanasabi Village within my farm land [C.S. Dag No.572 (Sht-3) under Patta No. 1123 (New) situated at 71-Laikot, Sawombung Sub-Division, Imphal East District, Manipur] of the value of about Rs. 8 lakhs (rupees eight lakhs) which includes all household and farm machineries. I myself rushed to the spot at around 8:00 am after taking verbal permission from the BSF personnel operated in the area on the same morning and found both farm houses burnt down to ashes on the ground.

The BSF personnel operated in the area are well informed being worked in the area.

I, therefore, request you to register an FIR and cause the culprits to arrest and punish in accordance with law.

The present information is laid in Imphal Police Station as it is impossible to proceed to the Yaingangpokpi Police Station due to curfew.
