Today i.e. on 23/06/2023 at @ 05:30pm received a reliable information stating that on the same day at around 05:00pm a large mob consisting of men and women including meira palbies and some youths detained 02 (two) unknown women at Ema Soubom Lairembi community hall, Sabungkhok Mayai leikai, IE on the allegation that the two women were Kuki militant's informers. The information further states that the mob tried to kill the said 2 (two) women by assaulting the two women. With the timely intervention, the two women were however rescued by Police personnel including women Police and evacuated to Raj Medicity for medical treatment. It is also informed that said Meira Paibis and the youths have been creating a terrorising situation or scene in the area.

In this regard the OC/YPI-PS registered a suo-motto case under FIR No. 117(06)2023 YPI-PS, U/S-147/148/149/325/354/307 IPC.
