## **SUB - FIRST INFORMATION REPORT**

It is to inform you that on dated 23 June 2023 from 0930 hrs a group of local Meitei Ladies started blocking the Road to Ukhrul near Yaingangpokpi market. At about 1050 hrs QRT party consisting of Sh Neeraj Kaushik, AC Coy Comdr of G Coy Ex- 100 Bn BSF a/with 03 SOs and 14 ORs (including G rep) Total-18 left the Coy location i.e. Emmanuel English Academy Boarding for ADP purpose in general area Thamnapokpi ,Urangpat, Gwaltabi and Monlengjang. At about 1255 hrs QRT party reachd at village Monlengjang where one of the PL of this Coy is deployed. QRT took position in the PL defences and at about 1300 hrs observed the movement of 04-05 armed miscreants in black uniform on the spur of nearby hill feature . They were 100 mtrs far from PS Yaingangpokpi and 400 mtrs far from PL location i.e. On challenging them the miscreants opened 4-5 burst of 15-20 rounds in the direction of PL post. In retaliation and to prevent the loss to the life and property of villagers of Monlenjang one of the QRT member namely No. 120908202 CT/GD Samar Ghosh opened three controlled burst of total 13 rounds with his personal weapon, AKM Butt No .06 and Body No . BA437797. 7.62 mm AKM rounds of Lot No. OFV 11 been fired. Miscreants flee the spot toping
