Sir,

I have the honour to state that, On 28-05-2023 at around 6:00 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 1000 persons carrying sophisticated weapons like AK Rifles, SLR, INSAS and .303 Rifles, forcefully entered our village, Molnomphai village, having 11 houses under Lhungtin Sub-Division, Kangpokpi District, Manipur having 11 houses about 20 Km East from Saikul-PS. They burnt down all our houses including Church, Church properties, Grainaries including one Two wheelers, to the ground leaving all of us homeless.

The approximate value of lost property is calculated at about Rs. 15,00,00,000/- (fifteen crores)

It is, therefore, requested to kindly register a regular case without delay and booked the culprits and take necessary legal action against them according to law.
