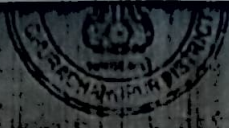

and they burnt down all the remaining things.

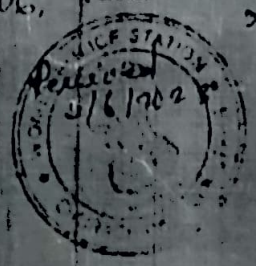
That while carrying out their above said criminal activities, the said Meitei radical groups
