
Sir,

I, the undersigned have the honour to state that a large number of unidentified people belonging to the Kuki community with deadly weapons and sophisticated arms including Kuki militant groups stormed the Meitei inhabited areas of Thamnapokpi, under Lamlai P.S, Imphal East District on the intervening night of 27/5/2023 & 28/5/2023. The said unidentified groups vandalized our house and looted our household materials. In such terrible acts of the said unidentified groups, I along with my family members ran away from Thamnapokpi, to save our life and taking shelter to our relatives at Lamlai. And started staying at the relief camp of Thamballeima High School, Iramsinhai Leirak Ashangba, since 3/6/2023. In that unfortunate incident I have lost my house and property amounting to a total amount of Rs:- 4,50,000/- (Four Lakh & fifty thousand) only.


It is therefore, requested kindly initiate and take necessary legal actions against the accused persons involved in the said inhuman and barbarous act, as per law of the land as early as possible. I couldn't able to submit my complain report in time due to prevailing inconvenient situation.
