Today i.e, 16/8/2023 at around 12.10.pm received a reliable information that the Lamlai Kendra Village Volunteer Force (LKVVF) organising a mass rally without any permission from the concern authorities which is starting from Sabungkhok village playground and destination at Gwaltabi village. Self along with ASP(Traffic)IE, SDPO/Chingai, SDPO/LLI, RL-2/IE, CDO/IE, home guard personnel from RI-IE and one coy of F-172 BSF Bn. went to the Sabungkhok village for controlling the crowd. Around more than 7000 to 8000 of men and women of Lamlai Kendra villages started their rally against the government order. The rally came up to Yaingangpokpi bazar towards Gwaltabi village. The Police party stop the rally at Yaingangpokpi bazar at around 1.00 pm. There some unknown persons misguide the crowd and forcefully trying to continue the rally. The police party using megaphone mic and warning to the crowed to disperse from there. Without obeying the police request the aggressive mob starts the rally forcefully by pelting stone to the police personnel. On that the police party fire some Stun bombs to disperse the mob. After the confrontation for about 2 hours the mob disperse from Yaingangpokpi bazar the situation came under control.
