Sir,

With due respect, I, the undersigned applicant begs to report you that on 28/05/2023 (Sunday), ~~at around 3:50 am~~ my house constructed at the homestead land under Patta No. 834 (Old), 984/1415 covered by C.S. Dag No. 1790, measuring an area of 0.09310 hectare, situated at Revenue Village No. 071-Laikot, Sawombung was gutted in a blaze. One of my locality, namely Tharoijam Memchatombi informed about the incident to me stating that some unknown miscreants with arms had started shooting towards our locality and had thereafter burned my house also along with other houses. Me and my family members were feeling insecure living at our house due to the communal feud of the State which started since 03.05.2023 and as such I along with my family members were staying at my sister house located at Nongmeibung on the said day of incident leaving behind all our belongings including luxury items.

In the Incident, I have loss properties worth Rs. 30,00,000/- (Rupees Thirty lakhs) only which proper description are given in separate sheet which is enclosed along with the present report. Further all the relevant documents/ registers along with all the materials i.e. utensil, height and weight machines, board, supplement, etc. supplied by the Government for running Anganwadi to me has also been destroyed/ burned.

In the above facts and circumstances, it is therefore respectfully requested that your goodself may kindly cause the arrest of the unknown miscreants who are involved in gutting a blaze of my house destroying all my and my family belongings and registered an FIR for the end of justice.
