Wherein, large gathering mob of Meitei community conspired and instigated by Meitei Leepul & Arambai Tenggol of valley based CSO's attacked on my/our Pangei and started vandalized, ransacking and burnt down my/our house rendering me in a state of Homelessness. Fearing to lose of our lives and being in a state of vulnerability, I, along with my family members numbering 1(male) 1(female) had fled and now taking refuge and shelter at the residence of Renting house.

That, the assets/properties and damaged were estimated to Rs. 394,000.

I, therefore, seek your kind intervention to register an FIR against the perpetrators and abettors for their heinous acts carried out against me and my family.
