Subject: - Report.

Sir,

I am to report that on 28th May, 2023 at about 3:30 a.m. as per information from the Control Room Imphal East District teams of CDO/IE Unit led by OC-CDO/IE under the command of Addl. SP(Ops)IE and Addl. SP(Traffic)IE under the supervision of SP/IE comprising of seven teams of CDO/IE Unit i.e. (OSCAR - 5, 12, 23, 27, 34, 36, 37) and two teams of CDO/IW had approached to Sabungkhok Khunou, Imphal East District stating that some well armed Kuki militants, mostly holding automatic rifles and sniper rifles, attacked the Meitei/Meetei by firing directly to the peoples and set ablaze the houses of the Meitei/Meetei located in and around the said area community. When our CDO teams reached Sabungkhok Khunou Village, Imphal East at about 4:30 a.m. of the day, the suspected armed Kuki Militants opened fired towards us. Immediately, our CDO teams had fire out a nos. rounds to retaliate the unknown suspected Kuki arm militants. In that, one personnel of my team (OSCAR - 19) namely, Const. no. 1815222 W. Chanson Singh was hit by explosion of Motar Cell at the neck which was fired by the said suspected armed Kuki militants.

Heavy exchange of fire between our CDO teams and the armed Kuki militants last till 7: 40^{am} of the day.

The above mentioned injured personnel of CDO/IE was hospitalized and provided medical treatment.

Therefore, I am being reporting this for your kind information and further necessary legal procedures.
