Subject :- Report

Sir,

I have the honour to report that on 18/07/2023 at around 09:30 pm, due to prevailing law and order situation, three teams of Heingang PS led by Inspt. Kh. Pathou Meetei, OC/HNG-PS, ASI Jaosinlung Malangmei and self conducted checking over the Naka Posts and security personnel stationed under the jurisdiction of Heingang PS. In that, two individuals were found loitering around Imphal Saikul road near Hundred Flower School, Haotal. They were immediately stopped and detained for verification. They identified themselves as (i) Kharibam Inaba Singh (35) yrs s/o (L) Kh. Kumar of Wangoi Mayai Leikai a/p Pangei and (ii) Hanjabam Henry Sharma (25) yrs s/o H. Haridas Sharma of Tangkham Awang Leikai. Upon frisking, they were found carrying 2 (two) nos. of country made pistols along with 5 (five) nos of 9mm live rounds. The arms and ammunitions were seized immediately from their possession by preparing seizure memo at 10:05 pm and they were arrested at 10:10 pm.

It is, therefore, requested you to kindly take up necessary legal action.
