These criminal broke my gate and looted every valuable property from my owned house and premises worth Rupees 24,17,000(approx) and they burnt down all the remaining things.

Fortunately, me and my family managed to escaped from from these criminal who even tried to killor burn us alive.

Therefore, with utmost respect I request you to take strong actions against the perpetrators by regisrered an FIR under relevant sections of the Indian Penal Codes.
