Subject:- Report on attempt to murder/crimes of vandalism and looting of properties/discrimination of Scheduled Tribes.

Dear Sir/Madam,

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the Paite Tribe, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989.

That, due to the prevailing ethnic crisis in and around Imphal, I along with my family left our residential quarter at Qtr. No. 72, 7th MR, Khabelsol, P.O./P.S Heingang, District-Imphal East on the 8th of May, 2023. And, it has come to our knowledge that our deserted quarter was attacked, destroyed and looted by a Group of radical Meetel/Meltels suspected to be members of Arambai Tengol and Meetel Leepun on the 16th of May, 2023 at around 3 PM.

The criminals broke open my door, destroyed and looted every valuable property from my house/ premises worth about Rs. 42,75,000/- (Rupees Forty Two Lakhs Seventy Five Thousand) only.

That, It may be reported here that the miscreants were shouting slogans like- " KANGLEIPAK YAIPHARE"; " KUKI HATLO"; etc. while they were carrying out their criminal activities. It seems to me that all these has taken place at the instance of the Manipur State Government as the perpetrators openly claimed and shouted that nobody would stop them, even the police because everyone, including top officials of the Manipur Government are patronizing them and that no harm could be done to them.

I, therefore, request you to kindly register my case and take stern action against the perpetrators under the relevant provisions of the law of our country.
