Sir,

I am to bring to your kind notice that I am a Scheduled Tribe (Kuki/Zo) and a resident of
S. Phailengkot village, Saitkul Block, Kuki

That, on the 31 May, 2023 at 6 a.m./p.m. my above said residence
(Owned/Rented) was attacked, destroyed, looted and burned by a Group of Meitei Mayek
radicals.

These criminals broke/open my gate(s), destroyed and looted every valuable property
from my "Owned / Rental" House, and premises worth Rupees... 22.5 lakhs (Approx)
and they burnt down all the remaining things.

That, while carrying out their above said criminal activities, the said Meitei Mayek
were shouting anti-tribal slogans like- "HAO HATLO", "KUKI HATLO", "HAO HATLO",
YAI PHARE", etc. Hence, the same can be taken as an insult on me and my family for being
tribal.

I, therefore, request you to kindly take strong actions against them and
registering an FIR/ Zero FIR under relevant sections of the statutes of our country.
