Sir,

With due respect, I would like to draw your kind attention to the following fact and submitting this information.

That, on the 20<sup>th</sup> of May in the early hours of the morning unidentified group of people believed to be the Arambai Tenggol, the Meitei Leepun, the Meitei ST Demand Committee and their other allied organization/societies broke into our house whereby they looted all our valuable belongings and properties, household furniture including sofa sets, beds, almirahs, clothes, ration, other essential commodities and various other valuable ornaments including gold earrings, gold necklace, gold rings, etc. They further damaged the leftover properties. The cost of the properties looted and destroyed are estimated to be around 01,75,00,000 (one crore, & seventy five lakhs).

You are therefore, requested to lodge FIR so that proper investigation can be done on time.
