That, on the 20<sup>th</sup> of May in the early hours of the morning unidentified group of people belived to be the Arambai Tenggol, the Meitei Leepun, the Meitei ST Demand Committee and their other allied organization/societies broke into our house whereby they looted all our valuable belongings and properties, house hold furniture including sofa sets, beds, almirahs, clothes ration, other essential commodities and various other valubla ornaments including gold earrings, gold necklace, gold rings, etc. They further damaged the leftover properties. The cost of the properties looted and destroyed are estimated to be around 01,75,00,000 9one crore, & seventy five lakhs).

You are therefore, requested to lodged FIR so that proper investigation can be done on time.
