I have the honor to state that following for favour of your kind notice and necessary action, please.

That on the intervening night of 03th May, 2023 and frequent attacked by Meitei miscreants including Arambal Tenggol, Meitei Leepun, Kangleipak Kanba Lup (KKL) and a women flock numbering about 1000+ member with sophisticated weapons and Assault Rifles like AK Rifles, License gun, Molotov, Knives etc, they entered into my residential at K. Vengnom Mantripukhri, near IGAR, PO, PS Heingang Station, Imphal East District, Mantripukhri and looted all my properties and destroy my house.

The estimated cost of the destroyed and looted properties roughly furnish here under.
