Subject: Report.

Sir.

I have the honour to state that, on 28-05-2023 at around 3:30 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations. Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 900-1000 persons carrying sophisticated weapons like Ak Rifles, SLR, INSAS and .303 Rilfes, forcefully entered our village, P. Phaimol village, I hungtin Sub-Division, Kangpokpi District, Manipur having 27 houses about 20 Km South from Saikul-PS. They fired several rounds of automatic weapons towards us for about 1(one) hours. So we fled from our village fearing lost of life.

They burnt down all our houses to ground leaving all of us homeless. In addition to, they also burnt down our Church, Community hall, Church Office, two tractors, 3 cars, 1 threshers, 1 Rice mill. groceries shops, 27 Grainaries.7 two wheelers etc.

The approximate value of lost property is calculated at about Rs. 50,00,00,000/- (fifty crores)

· It is, therefore, requested to kindly register a regular case without delay and booked the culprits and take necessary legal action against them according to law.
