Subject:- Request to file FIR against Miscreants for destruction and looting of property.

Sir,

In inviting a reference to the above cited subject above, I have the honour to report that on 18th May, 2023 due to communal violence spread across Imphal Valley towards the Kuki-Chin-Mizo tribe by some dadical sections of the majority valley based organization namely Meetei Leepun and Arambai Tengol, my House Located at Khabam Chumbreithong 9K. VENGONOM), IGAR South, Imphal East have been at the receiving end of most inhuman activities by the radical mob. On 18th May, 2023, Volunteers believe to be from the aforementioned radical organization attacked, robbed and destroyed the colony including my House.

Since, the incident was very sudden, we had no time to packed anything including important documents and valuable items nor could we file an FIR at Police Station earlies. In the process they have looted all valuable items including cash, documents and jewellery, later they destroyed and burnt down various items in and around the home compound. The details of property affected is enclosed as ANNEXURE-I.

In this regard, I am to request you to kindly take up further necessary legal actions against those miscreants involved in theft and destruction of Property.
