Subject:- Report on looting, vandalism and burning of house, household items/assets

Sir,

With reference to the above cited subject, I have the honour to report to you as follows:

1. That, I Seingam Touthang aged about 61 years, H/o Hatneithing belonging to the Kuki tribe/community, a Schedule Tribe recognized under the India, by virtue of which I am being entitled to the protection under The SC/ST (Atrocities) Act, 1989. and that, I am a permanent resident of Twichin Yaingangpokpi District, Manipur-795 Kangpokpi.

2. That, at about 4 am/pm on the 4th June 2023, a huge contingent of Meeitei/Meitei suspected to be members of the Arambai Tengol and Meitei L. various state forces like Manipur Police Commando and Indian Reserve Battalion villages and in the process, they have looted, vandalized and torched my house.

3. That, it may be reported here that the above said criminal activities have caused and incurred huge loss which may be estimated to be Rs 20 Lakhs Twenty Lakhs only.

4. Fortunately, me and my family managed to escaped from these criminals who burn us alive, and now currently taking refuge at Thengzer Churachandpur.

In the given circumstances, I humbly pray you to kindly register an FIR ZERO matter and punish the perpetrators as per the prevailing provisions of the laws of which act of kindness, I shall always remain thankful to you and obliged.
