Subject :- Request for Registration of Zero FIR.

Sir,

I, Nianghuamkim Ngaihte D/o Ginzamuan Ngaihte of Mantripukhri, Imphal, am bringing to your kind notice that on the 3rd May, 2023 (in broad daylight) my residence was attacked by a group of Meitei mobs.

These goons immediately broke my compound gate and vandalised, looted and burnt down all my valuable properties within the house with the total worth (approx) Rs. 5,16,00,000 (Five crores and 16 lakhs) only. Amidst the criminal activities, I along with my family members managed to escape because of Divine grace and fled to Assam Rifles Mantripukhri for our safety and finally left the camp on 18/05/2023.

Therefore, I request you to kindly take strong actions against the perpetrators by registering Zero FIR under relevant criminal sections of Indian Penal Codes.
