Amidst the criminal activities, I along with my family members managed to escape because of Divine grace and fled to Assam Rifles Mantripukhri for our safety and finally left the camp on 18/05/2023.

Therefore, I request you to kindly take strong actions against the perpetrators by registering Zero FIR under relevant criminal sections of Indian Penal Codes.
