Sir,

I, **Daltumsuan H/o Nlangneiching** of Mantripukhri, Imphal, am bringing to your kind notice that on the 3rd May, 2023 (in broad daylight) my residence was attacked by a group of Meltel mobs.

These goons immediately broke my compound gate and vandalised, looted and burnt down all my valuable properties within the house with the total worth (approx) Rs. 3,12,000 (Three crores and twelve one lakhs) only. Amidst the criminal activities, I along with my family members managed to escape because of Divine grace and fled to Assam Rifles Mantripukhri for our safety and finally left the camp on 08/05/2023.

Therefore, I request you to kindly take strong actions against the perpetrators by registering Zero FIR under relevant criminal sections of Indian Penal Codes.
