Sir,

I have the honour to state that, on 20/06/2023 at around 03:00 pm some unknown miscreants members of Meitei Youth Organizations, Meitei Leepun, Knagleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 1000-1500 persons carrying sophisticated weapon like AK Rifles, SLR, INSAS and .303 Rifles, Forcefully entered my locality at K. Vengnom Khabam Manung Leikai, Mantripukhri Imphal East District Manipur about 45 Km south from Saikul-PS. They vandalising my house and looting all the moveable properties, Furnitures, Jewellery, utensils, Cloths, important document, Kitchen Wares, Electrical and Electronic items, Books, Cash, including for newly construction of houses material like tile, cement, and leaving us homeless.

The approximate value of lost property is calculated at about Rs. 80,00,000/- (Eighty lakhs)
